## MEDICO-LEGAL EXPERIENCE

I have extensive experience of carrying out a range of psychiatric assessments and writing independent reports for a number of different courts (including civil and criminal court), since 2011.

I am the CEO of a medico-legal practice; Sigma Delta Psychiatry Expertise. Professional website: [www.sigmadeltapsych.co.uk](http://www.sigmadeltapsych.co.uk)

I am co-founder of North London Medico-Legal forum – a Continued Professional Development Group for psychiatric medico-legal experts; this is a consultant-only quality-control forum, where we regularly assess each other's reports, and give feedback.

I have authored around 500 criminal court reports and around 500 civil court reports in my career (at a ratio of around 40% for the Claimant, 30% for the Defendant and 30% as joint instructions). My current turn-over is around 3 reports per week (around 150 reports per year).

I work part-time in my current Forensic Psychiatrist role (in two Criminal Court Liaison and Diversion schemes for the NHS). Therefore, I am able to dedicate several days per week to carry out medico-legal work. I am generally able to see clients and turn around reports very quickly.

## CIVIL COURT EXPERIENCE

- Personal injury cases – assessing a range of psychiatric damage. I specialise in complex and high value cases.
- Clinical Negligence – assessing a range of issues, such as breach of duty, causation and condition and prognosis. I specialise in complex and high value cases.
- Historical sexual abuse.
- Psychiatric consequences of a wide range of incidents and accidents (e.g. Post-Traumatic Stress Disorder, issues at work, physical disability, Grenfell Tower trauma).
- Detailed prognosis and recommendations for psychiatric treatment.

As well as adults, I have carried out multiple assessments of children and adolescents.
